is not an inhabitant of this State...said defendant [is called upon] to appear and answer the bill of the complainant at the next term of the court. June 12th, Seth J.W. Lucky, clk. & master.

The Bill charges...that in the year 1825, the complainant purchased a tract of land in Washington county, containing 152½ acres, from a certain Henry McCray, for which he gave \$1400, and has paid the whole of it, that McCray failed to execute the deed at the time he stipulated, but on a different day, when complainant was not present; and to shield himself from responsibility, he executed to George Jenkins a deed for said land, but for the benefit of your orator. The bill further charges that one Jacob Ellis, now deceased, pretending to have some claims against respondent, by confederation with the said Jenkins, procured him to execute a deed to the said Ellis for the said tract of land, which deed, it is alleged, was received by the said Jacob Ellis as the trustee of the complainant. Complainant further charges that he did not owe the said Jacob any thing, nor is he indebted to his estate, that the executor of the said Jacob have instituted an action of ejectment against the complainant for the purpose of him out of possession. The prayer of the bill is that the executors of the said Jacob Ellis may be perpetually enjoined from disturbing complainant in the possession aforesaid of his lands, that the legal title may be divested out of the said Jenkins or whoever else it may be in, and vested in the complainant.
